The Minor Variance application concerns the property, which is known as CON 9 PT LOT 19 RP 26R2397; PART 3, Municipality of Mississippi Mills, known municipally as 5859 Martin Street North (Ramsay Ward).

#### PURPOSE OF THE APPLICATION

The applicant is requesting relief from the provisions of Sections 8.16 (2) and 8.16 (5) of Zoning By-Law #11-83 to permit a detached secondary dwelling unit located outside of a settlement area that is larger than 40% of the gross floor area of its principal dwelling unit. Section 8.16 (2) limits secondary dwelling units to settlement areas and requires that they are contained within the same building as its principal dwelling unit. Section 8.16 (2) requires that secondary dwelling occupy less than 40% of the gross floor area of its principal dwelling unit. The subject property is zoned Rural (RU). The Minor Variance request is outlined below.

8.16 (5)	Size of the Secondary Dwelling Unit	A secondary dwelling unit must not be greater in size than an amount equal to 40% of the gross floor area of its principal dwelling unit	A secondary dwelling unit that is greater in size than an amount equal to 40% of the gross floor area of its principal dwelling unit
