Purpose of the Application:	The subject property is zoned Residential Second Density (R2). The applicant is seeking relief for a proposed development consisting of a two-storey, vertically separated triplex (3-unit townhouse) with a reduced exterior side yard setback of 5.82 metres; a reduced rear yard setback of 6.48 metres; and a lot coverage of 45% whereas Section 14.2 of the Zoning By-law requires a minimum exterior side yard setback of 6 metres; a minimum rear yard setback of 7.5 metres; and, a maximum lot coverage of 40%. A porch that projects into the exterior side yard setback by 2.13 metres is also proposed whereas Section 6.29 of the Zoning By-law limits the permitted projection to 2 metres.
