\$300.00 ON GROUND, TRAILER TYPE (60 DAYS)

- The undersigned hereby applies for a permit to build according to the plans, specifications and Block Plan herewith submitted, and agrees to comply with the Ontario Building Code and all Municipal By-laws and Regulations, it being expressly understood that the issuing of a Permit does not relieve the applicant from complying with all said Code, By-laws and Regulations, though not called for in the specifications or shown on the plans submitted.
- The applicant further agrees that if a Permit is revoked for any cause or irregularity or non-conformance to the said Code, By-laws or Regulations, that, in the consideration of the issuance of the Permit, all claims are waived arising therefrom against the Corporation of the Municipality of Mississippi Mills.
- In all cases signs must meet requirements of current Sign By-law. Signs must not obstruct view of traffic (sight triangles). Signs must be kept in a state of good repair, the judgement of which will be at the discretion of the Chief Building Official.
